WHAT WE NEED FROM YOU:

1. Criminal History Report from the court where you were convicted or DOJ Live Scan Report;
2. Confirmation that your fees have been paid, *if this has not been completed we can still assist although we cannot guarantee your request will be approved.

ELIGIBILITY:

- You must reside in Riverside or San Bernardino Counties;
- Prior convictions must have been in California;
- You must not be on probation or have an active open case.

ELEGIBILIDAD:

- Debe vivir en los condados de Riverside o San Bernardino;
- Las condenas previas deben haber sido en California;
- No debe estar en libertad condicional;
- No debe tener un caso activo o abierto.
