AB 672

AB 672 expands the Civil Rights Department's authority to proactively offer community assistance in resolving disputes related to discriminatory practices while maintaining confidentiality.

AB 772

AB 772 defines exempt child daycare facilities as “drop-in childcare centers,” requires these centers to obtain a written health assessment for children if a medical assessment is unavailable.



AB 1801

AB 1801 revises supportive housing requirements to permits up to 25% of total floor area for administrative office space used by nonprofits, explicitly includes transitional housing for youth.



AB 1877

AB 1877 enhances juvenile record sealing processes by requiring probation officers to petition for sealing records once an individual turns 18 and juvenile court jurisdiction ends.



AB 2556

AB 2556 requires health care service plans and insurers to annually provide notices to enrollees and insureds about the benefits of behavioral health and wellness screenings for children and adolescents aged 8 to 18.



AB 2995

AB 2995 updates alcohol and drug services laws to use person-first language, eliminate stigmatizing terms, and ensure respectful, inclusive treatment through technical and conforming changes.

AB 518

Requires the State Department of Social Services, by July 1, 2025, to develop a methodology for estimating CalFresh participation rates, identifying eligible but unenrolled individuals, and creating targeted outreach strategies.

Human Services Listening Session

Non-Profit Summit

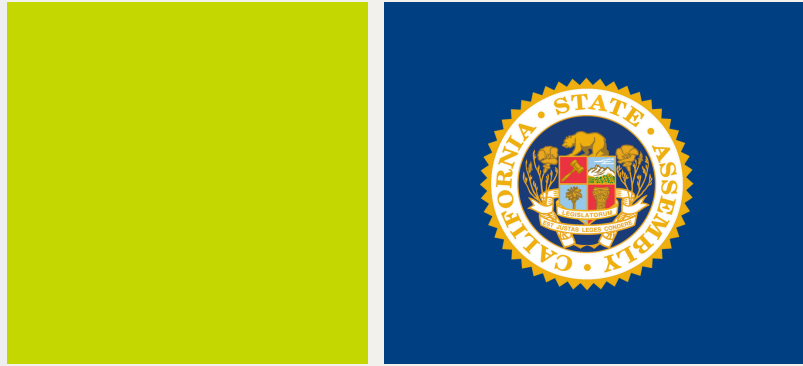
Hosted our annual Non-Profit Summit to provide a free workshops and educating new and experienced non-profits on how to better prepare, organize, fundraise and manage themselves.

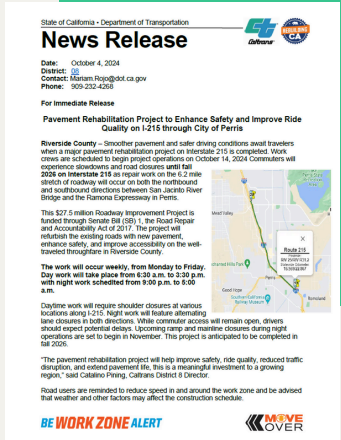




2024 Projects

215 Freeway

Our commitment to improving our community has secured the \$27.5 million 215 Freeway Roadway Improvement Project through Senate Bill 1. This initiative will enhance safety, accessibility, and efficiency with new pavement and vital upgrades, benefiting all who rely on this essential route in Riverside County.



Organized Retail Theft

I communicated my stance and the actions we took through mailers to keep you informed. Together, we worked to protect our businesses, support public safety, and strengthen our community in the 60th Assembly District by voting in favor of **SB 108 - Budget Act**, which equips law enforcement to fight retail crime, keeping you safe and protecting your quality of life.



RCTC Metrolink Station

Through advocacy and support, the California State Transportation Agency recently awarded \$40.5 million in grant funds to the Riverside County Transportation Commission (RCTC) to support the development and construction of a new Metrolink station and mobility hub along Interstate 215 in the unincorporated Mead Valley area.
